REGULATIONS MINI PIENINY ULTRA-TRAIL[®] 2024

1. Objectives of the event:

- popularization of sport and sports activity among children and youth,
- popularization of running as a form of spending free time for whole families,
- promotion of environmental awareness among children and youth,
- promotion of safe running among children and youth.

2. Organizers of the event:

3. Date and place

Mini Pieniny Ultra-Trail[®] will take place on April 21, 2024 (Sunday) in Szczawnica in the Lower Park and on the surrounding forest paths.

4. Rules of participation and registration:

- Participants of the Mini Pieniny Ultra-Trail[®] can be any child up to 17 years of age, who will be registered for the competition by a parent or legal guardian.
- Applications can be made electronically at <u>www.zapisy.strefaprzygod.pl</u>.
- The application is made by a parent or legal guardian providing their data and child's data during the registration.
- Registration for Mini Pieniny Ultra-Trail[®] 2024 will start on November 7, 2023 and will last until:
 - Electronic registrations until April 17, 2024
 - Registration at the competition office April 19-20, 2024 during operating hours of the Pieniny Ultra-Trail[®] race office*
 - or until the limit of places is reached 400 participants.

*Registration at the competition office lasts only when the limit of the starter packages produced is reached, there is no guarantee that there will be enough packages for everyone who comes to the office, so we encourage you to register electronically in advance.

 The parent is responsible for the correctness of the child's data entered into the registration system at the time of enrollment.

5. Courses

Participants can compete in the following age categories:

D0 - up to 3 years (2023 -2021) - distance approx. 100 m; D1 - 4-5 years (2020 - 2019) - distance approx. 200 m; D2 - 6-7 years old (2018 - 2017) - distance approx. 300 m; D3 - 8-9 years old (2016 - 2015) - distance approx. 400 m; D4 - 10-11 years old (2014 - 2013) - distance approx. 600 m; D5 - 12-13 years old (2012 - 2011) - distance approx. 900 m; D6 - 14-15 years old (2010 - 2009) - distance approx. 1 km (+30 m/-30 m elevation gain); D7 - 16-17 years old (2008 - 2007) - distance approx. 2 km (+60 m/-60 m elevation gain).

- The courses are routed along park and forest paths of various surfaces and are cross-country. Routes for categories D0 - D5 are leading around the Lower Park in Szczawnica along park alleys, in flat terrain. The routes for the D6 and D7 categories go beyond the park in part of the route and have an ascent and descent with an elevation gain of about 30 m, for the D7 route there are two loops, i.e. an elevation gain of +60 m.
- During the run, participants are obliged to move only along the route indicated and marked by the Organizer.
- With the exception of categories D0 and D1, parents are not allowed to run with their children and accompany them along the route.
- Age categories will be assigned based on the child's date of birth.
- It is not possible to participate in the race in a category older or younger than the category for the child's date of birth.

6. Benefits

As part of the packages, we provide participants with:

- accident insurance,
- buffet at the finish line,
- bib number,
- electronic time measurement for categories from D2 to D7,
- souvenir medals for participants who finish the run,
- medical protection,
- route marking.

7. Starting fee:

The starting fee is:

PLN 25 paid by February 29, 2024,

- PLN 30 paid from March 1, 2024 to April 17, 2024,
- PLN 40 paid at the competition office.
- After registering the application, the participant's data will be automatically published on the starting list on the event website.
- Only a full application and payment of the entry fee to the account indicated in these regulations and on the competition website are counted. The confirmation of registration is the participant's appearance on the starting list on the competition website, as well as a message sent to the e-mail address provided during registration.
- The entry fee is not valid if the participant is not registered electronically, if it was
 made after the deadline or if it is paid after the limit of places has been reached.

8. Entrance fee refunds

The return of the entry fee in the event of early resignation from the start and effective notification of the Organizers is possible under the following conditions:

- in the event of resignation from the start by February 29, 2024, the amount of the entry fee will be refunded after deducting the handling fee of PLN 5,
- in the event of resignation from the start from March 1 to March 31, 2024, 50% of the entry fee will be refunded,
- resignation after March 31, 2024, during the race or failure to appear at the start of the competition does not entitle to a refund of the entry fee.

9. Receiving packages

- Packages collection is possible on Friday, April 19, 2024 and Saturday, April 20, 2024 at the main Pieniny Ultra-Trail[®] Race Office, located at the Pieniny Car Park near Dunajec river or on Sunday, April 21, 2024 in the Lower Park in Szczawnica.
- All participants taking part in the race must be verified at the Race Office.
- The condition for allowing them to start is the presence of a parent or guardian with an ID card at the time of verification of the participant in the Race Office.
- When collecting the package, the parent or legal guardian shows an ID card or other document with a photo.
- Each participant will receive a bib number and a chip (cat. from D2 to D7) at the Race Office.

10.Safety

 The organizer draws the attention of the person exercising parental authority or custody of the child to the multiplicity of dangers and threats resulting from participation in a sports event, related to high physical effort, which may include, among others, at the risk of loss of life and health. The organizer recommends that before starting preparations for the race and during preparations, the child undergo appropriate medical examinations or medical consultations, depending on the child's age and physical condition.

- The organizer is insured against civil liability towards the participants of the run.
- The organizer provides the participants of the run with accident insurance.
- The organizer does not provide any life, health or civil liability insurance for illness, accident, injury, death or any loss or damage that may occur in connection with the presence or participation in the races.
- The condition for participation in the run is the authorization of medical and paramedical personnel employed on behalf of the Organizer to provide first aid or perform other medical procedures, including transport of the injured participant to a safe place.
- Medical services or the organizer of the competition may prohibit further continuation of the run by the participant if there is a suspicion of poor health threatening the life or health of the participant.
- By accepting these Regulations, the parent or legal guardian confirms that they know that participation in the run involves physical effort and entails a natural risk and risk of accidents, the possibility of bodily injury and physical injury (including death).
- Providing the Organizer with a correctly completed registration form, paying the registration fee means that the parent or guardian has considered and assessed the nature, scope and degree of risk related to the child's participation in the race and has voluntarily decided to take this risk by participating in the race solely on your own responsibility.
- The condition for participating in the run is to have an appropriate and current medical examination allowing the child to start in the selected run or to accept during registration a statement regarding the participant's health and the absence of contraindications to participate in the competition.

11.Competition and Prizes

- The classification is based on electronic time measurement. There will be a control mat at the finish line, which records the appearance of the participant. Failure to read the participant may result in his disqualification.
- The general classification is based on gross times counted from the start of the race.
- In the final results of the run, each participant receives information about the gross time.
- Unofficial results of the run will be posted on the website www.pieninyultratrail.pl immediately after the run.
- Written protests regarding the results are accepted until April 23, 2023, at 18.00 to the e-mail address: info@pieninyultratrail.pl. Protests will be considered within 24 hours and the final and official results will be published no later than April 24, 2023.
- In the age categories: D0 and D1, there will be no winners. All children will receive a souvenir medal.

 In the age categories D2, D3, D4, D5, D6, D7 the run is a competition, all children will receive a souvenir medal, statuettes will also be awarded for places 1-3, separately in the girls' and boys' category.

12.Image protection and personal data

- In order to participate in the race, the parent or legal guardian must sign an appropriate statement during registration regarding the consent to the free use of the participant's image and a statement regarding the processing of the participant's personal data.
- The condition for participation in the run is also the consent of the person exercising parental authority or custody of the child to the processing of the participant's personal data provided in the application form by the personal data administrator within the meaning of the Personal Data Protection Act of May 10, 2018 and the general regulation on data protection no. 2016/679 of April 27, 2016 (GDPR), which is the Strefa Przygód Foundation with its registered office in Strzałkowo (postal code: 62-420 Strzałkowo), Staw II 12/17, for the purpose and to the extent necessary to carry out the event, including the publication of the participant's data on the starting lists and lists with results and sending the participant's result to the telephone number indicated during registration, in accordance with art. 8 sec. 1 GDPR.
- A person exercising parental authority or custody of a child has the right to request access to the participant's data, rectification, deletion or limitation of processing and to object to processing, as well as the right to transfer data. Providing the child's personal data is voluntary, but necessary to participate in the event.
- Participant's data may be transferred to entities cooperating in the implementation of the event and related actions, on the basis of appropriate entrustment agreements.
- Personal data will be stored for the period necessary to carry out the event, the details of storing specific data are specified in the Privacy Policy.
- A person exercising parental authority or custody of a child has the right to lodge a complaint with the President of the Personal Data Protection Office when he/she considers that the processing of personal data concerning the participant violates the provisions of the General Data Protection Regulation No. 2016/679 of 27 April 2016 or the provisions of the Act on the protection of personal data of May 10, 2018.
- The administrator may process personal data in connection with the organization of the Mini Pieniny Ultra-Trail[®] event also in cooperation with other persons, e.g. volunteers, who carry out activities related to the organization and course of the event.
- Details regarding the protection of the participant's personal data are specified in the Privacy Policy.

13.Protests

- The organizer accepts official protests regarding violations of the competition rules on April 21, 2024 until 11:50. Protests submitted after this date will not be considered.
- Protests can be submitted in writing to the following address: info@pieninyultratrail.pl or in person at the race office located at the finish line of the competition.
- The organizer considers protests in the shortest possible time, maximum within 24 hours.
- All complaints, comments and requests regarding matters related to participation in the event can be submitted within 14 days from the date of its completion, in particular to the Organizer's e-mail address or in writing to the Organizer's correspondence address, with the note "Complaint". The Organizer recognizes complaints within 14 days from the date of their delivery to the Organizer.
